Monthly Message

May 5th, 2026, is World Asthma Day.

The Global Initiative for Asthma (GINA) theme for World Asthma Day 2026 is: “Access to anti-inflammatory inhalers for everyone with asthma – still an urgent need”.

The Seabreeze STAT study requires that participants receive treatment with low, medium, to high dose inhaled corticosteroids.

What is new in GINA 2026?

On World Asthma Day, ERS and ATS held a webcast to provide an update on the changes in GINA 2026.

- Four new acute asthma flowcharts for primary care and ED settings with criteria for mild to life-threatening presentations
- New decision tree for biologic selection in severe asthma with type 2 inflammation
- Defined risk markers for fatal asthma: prior intubation, recent hospitalization/ED visits, current or recently stopped OCS. Warning on SABA toxicity mimicking worsening asthma.

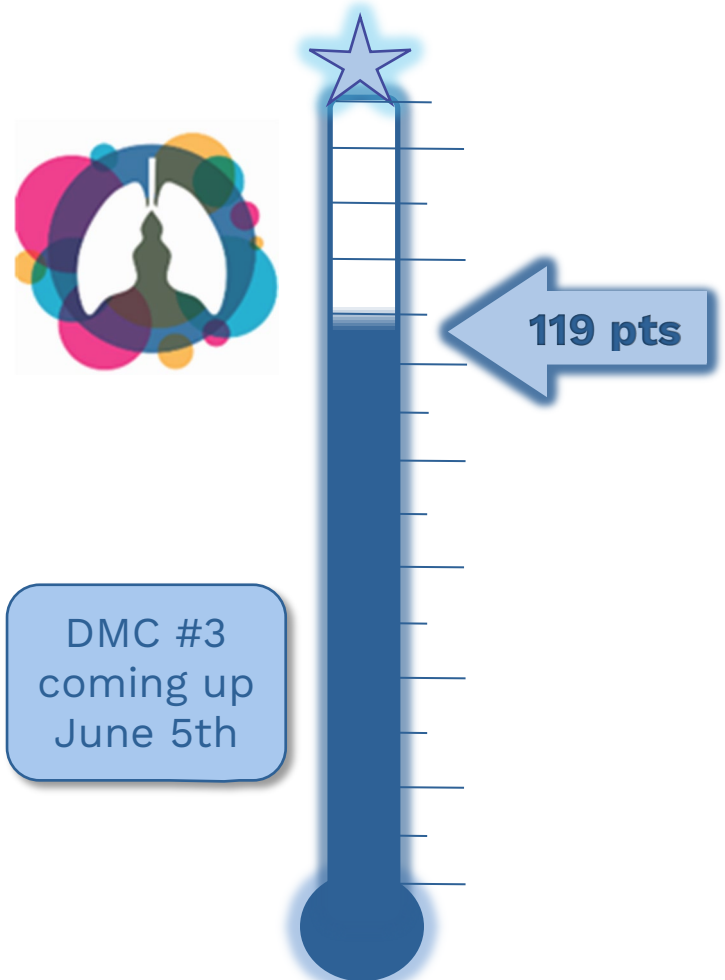

Questions & Answers

Q. If a patient had asthma in childhood that later resolved, does a subsequent adult asthma diagnosis restart the clock on asthma duration for eligibility purposes?

A: No. The ≥ 12 -month asthma history requirement is based on the initial physician diagnosis of asthma, as supported by medical records or patient report. A prior diagnosis in childhood satisfies this requirement even if symptoms resolved and asthma was later re-diagnosed in adulthood. All other inclusion criteria must also be met.

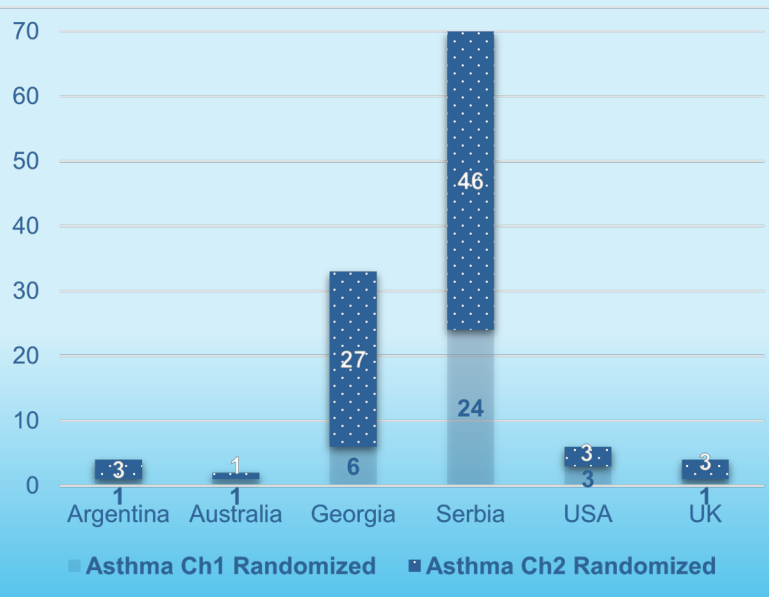
Q. If local lab provides only serum urea, can sites calculate BUN values for eligibility?

A: Yes, however this is a protocol deviation since BUN is required. The calculated BUN should be entered.

Q. Is an urgent healthcare visit required for eligibility at Visit 1b?

A: Yes. Per protocol, a participant is eligible at Visit 1b only if the index asthma exacerbation required an urgent healthcare visit for treatment. This refers to the level of care needed, not a specific facility. For the purposes of this trial, an urgent healthcare setting may include an ED, a hospital inpatient ward, an urgent healthcare facility, or an outpatient clinic equipped to provide the protocol-specified level of care. If the participant's index exacerbation required a visit in any of these settings, then this requirement is satisfied.
